Statutory Statement

The CPD Carnet allows travelling between countries on non-commercial tourist trips without the need for immediate customs guarantee at the border. I undertake, as owner/operator of the vehicle described in the application, even in case I have authorized another person to procure a CPD carnet for me, which allows the temporary export and import of vehicles within the framework of tourist and non-commercial journeys, that the vehicle to which the CPD carnet in question (hereinafter referred to as the carnet) has been issued by Ústřední automotoklub České republiky (hereinafter UAMK CR/Autoturist) will be exported from the country/ies within the prescribed period. This customs document with confirmed entries and exits from all countries for which it was used shall be returned to UAMK CR/Autoturist no later than 14 days after its expiry date. If I do not meet this deadline, I will pay UAMK CR/Autoturist a fee of 700 CZK for each commenced week of delay.

I further undertake not to leave the vehicle abroad without the permission of competent authorities and without consciousness of UAMK CR/Autoturist. I declare that I am aware of the consequences of the unauthorized leaving of the vehicle abroad resulting from the provisions of the Customs Law. In case the vehicle is left abroad with the consent of competent authorities, I undertake to make a customs clearance of the vehicle with the customs authorities, in terms of customs formalities, and to ensure that the customs carnet issued is recorded. The carnet processed in this way will be returned immediately to UAMK CR/Autoturist.

In case I am not able for any reason to leave the country, which I entered with my vehicle under the customs guarantee of the CPD until the end of the period of validity of the carnet, I undertake to present the carnet to UAMK/Autoturist and to request an extension of its validity period for the strictly necessary period. The fees for this extension and other eventual costs will be paid to UAMK CR/Autoturist according to the valid price.

I also undertake to pay UAMK CR/Autoturist immediately upon his first request full customs duties, value added tax, excise duty, countervailing import fees and other potential fees paid in the customs clearance on the basis of generally binding legislation (interests on late payments, fines, road tax, etc.), which UAMK CR/Autoturist as a guarantor would have to pay directly or indirectly to foreign customs or other offices due to the fact that I did not return the customs document to the UAMK CR/Autoturist in time or that it was not properly processed in respect of entries and exits from foreign countries. I will also pay UAMK CR/Autoturist all expenses related to the handling of the case.

I further undertake to return UAMK CR/Autoturist this carnet before performing a major repair on the vehicle (replacement of the engine etc.) or before the sale of the vehicle, even if it is still valid. I take into account that I am liable for all damages that would have been incurred to UAMK CR/Autoturist due to the use or abuse of the carnet by a third party or the theft of the vehicle abroad.

As a guarantee for the payment to UAMK CR/Autoturist, I pay a deposit. I take into account that this deposit will be returned to me within a period of approximately 24-26 weeks after the return of the duly executed carnet and after its final examination by the competent foreign authorities, and after deduction of potential expenses. The deadline is indicative, depending on the number of countries where the carnet has been applied and may be extended even if the carnet is used to visit countries where higher deposit is required. If I do not return the carnet, I will pay UAMK CR/Autoturist a contractual penalty equal to the amount of the paid deposit. UAMK CR/Autoturist is entitled to offset the deposit against payment of the contractual penalty. Payment of the contractual penalty does not exclude compensation for damages and costs incurred to UAMK CR/Autoturist related to non-return of the carnet.
